#### **AFTERNOON CONCURRENT SESSIONS**

A NIGHTMARE ON CALPERS STREET (SB 278) – Steve Berliner, Liebert Cassidy Whitmore

SB 278 greatly increases employer exposure to costs and penalties for errors. SB 278 makes employers pay back overpayments in CalPERS benefits made to retirees who have part of their compensation disallowed. This is a complete reversal of the prior law. The legislation became effective on January 1, 2022 but agencies still have the opportunity to reduce their potential liability. All agencies should review their MOUs as well as the actual practices of its payroll department to ensure that compensation reported is allowed under the law. This presentation will discuss what the law does, describe some of the key problem areas to review, offer suggested MOU language, and discuss the meet and confer considerations.

#### **NEGOTIATIONS DURING INFLATIONARY TIMES** – Alfonso Estrada, Hanson Bridgett

Contract negotiations are always a challenge, but in the past year they have become even more so, with record levels of inflation leading to employee demands for greater salary increases.
