All of this will be against the backdrop of current state SGMA implementation plans, including state plans for dealing with unmanaged areas; unresolved GSA formation and boundary disputes; and other pending issues left over from the GSA formation phase. We will have a panel with tips for resolving SGMA disputes without going to court.

Finally, we wrap up with a panel on financing options including state resources and strategies for cost recovery under Proposition 218. We hope you will join us for this very timely and informative conference.
