Top AALRR Trial Lawyers and Three Judges Train Associates During Intensive Trial Academy

On August 18-20, 2016, Atkinson, Andelson, Loya, Ruud & Romo (“AALRR”) held its inaugural Trial Academy for 16 specially selected associates. AALRR’s Trial Academy is a fast-paced, deep dive into trial strategy and technique, designed to provide associates with first-rate litigation skills.

The second day was dedicated to videotaping each associate giving opening arguments and conducting direct and cross-examinations, followed by a critique session by two or three experienced AALRR trial attorneys, who provided the associates with specific tactics for improvement. On the final day, each associate gave a closing argument. Then everyone was treated to a panel discussion from three judges on the “Do’s and Don’ts at Trial.”
