NLRB Roundtable

Recently we have seen significant new case law from the National Labor Relations Board and important policy changes by the Board’s General Counsel. The Regional Directors of Regions 21 and 31 of the NLRB will be joined by experienced practitioners who will share their thoughts on recent developments at the Board. This year’s presentation will focus on the legal nuances and real-world practicalities of Board decisions covering such issues as independent contractor status; what it means to engage in protected, concerted activity in the workplace; the successorship doctrine; and more. The panel will also discuss the implications of the General Counsel’s approach to allegations that a union has breached its duty of fair representation to employees with respect to grievance-handling, notification of employee rights under General Motors and Beck, and dues revocation.

WORKSHOP III:
Independent Contractor or Employee? The California Supreme Court has Spoken, but Federal Agencies and Business Groups Aren’t Buying It

New business models hope to replace traditional employment with independent- contractor relationships. Last year, however, the California Supreme Court issued a unanimous ruling in Dynamex that makes it harder for companies to classify workers as independent contractors. Business is fighting back in the legislature, while the NLRB has issued new rulings protecting independent contractor relationships from attacks by labor unions and employees. Our distinguished panel will provide insights on when workers are really employees, and whether they have legal protections when they organize or engage in group job actions. Our speakers will also explore legislative proposals for reworking or expanding the traditional employer-employee relationship to include workers in the gig economy.

The Future of Public Sector Labor Relations After Janus v. AFSCME

The right to work movement has attacked mandatory union fees and dues in the public sector. As a result of the Court’s June 2018 ruling in Janus, public sector employees no longer can be required to pay fees and dues as a condition of employment. Since the Court’s ruling, public sector unions have actively taken steps to protect themselves and their members. Also, California legislation, recent strike activity, and litigation since the Janus ruling have all impacted both employers and employees in the post-Janus public sector workplace. What is the impact of Janus? Are unions weakened? Are they more energized? How are public employers affected? Experienced practitioners will discuss these issues.
